



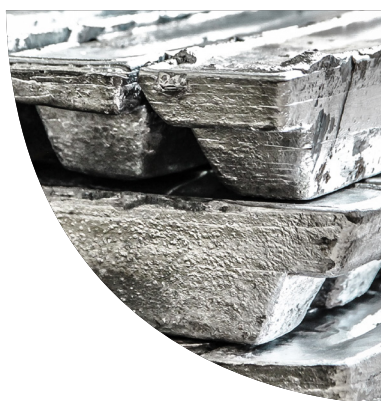

Recycling Process



Waste collection: Gathering waste materials from industrial operations for treatment and repurposing into new products.



Refining: Separation and purification of waste materials gathered, in order to remove impurities and prepare them for recycling (return process without contaminants).



Mixing: Add additional additives to a substance, enhancing its properties or performance.



Quality controls: Test and inspection of the products at various stages of production to ensure that products meet specific quality standards.



Packaging: The product is packaged in recycled packaging.
